

- At the beginning of his career from 2000 to 2004 he worked in the audit and advisory firm Deloitte d.o.o., one of the largest global audit and advisory firms (Big4), on numerous audit and advisory assignments in Croatia, Bosnia and Herzegovina and Kosovo, and due diligence projects for privatizations, mergers and acquisitions in Croatia.
- In the period from 2004 to 2006 he worked in the consulting firm Deloitte savjetodavne usluge d.o.o. on management consulting assignments, primarily on restructuring projects, strategy development and strategy implementation projects, all in large organizations.
- From 2006 to 2011 he worked in the company Papyrus Croatia d.o.o., a member of Papyrus Group with headquarters in Sweden, one of a leading paper merchants in Europe, where he worked as the finance director, responsible for operations in Croatia, Slovenia, Bosnia and Herzegovina, Serbia, Macedonia, Kosovo and Albania.
- From August to December 2011 he held the position of management board member and CFO of Magma Inc., responsible for developing a restructuring plan, and negotiations with key creditors in relation to the refinancing of debt to financial institutions and debt to equity swap of other creditors.
- Since December 2011 until May 2012 he worked as an independent contractor on a restructuring project and providing advisory services, and since May 2012 he is the co-founder and CEO of Turnaround Ltd (Croatian: Preokret d.o.o.).
